

## **Instructions to Authors**

### **Manuscript Submission**

Authors are invited to submit their manuscript for publication as Research paper, review papers, and short communications properly formatted as per the author's guidelines to [pmsst21@gmail.com](mailto:pmsst21@gmail.com) along with copyright form. Authors are requested to go through our instructions and also to download a few of our articles, read them carefully before preparing a submission so that the article matches our given format. We expect high-quality research articles that are free from plagiarism and any unethical publication mode.

**Language:** The Journal's language is English. British English or American English spelling and terminology may be used.

### **Manuscript presentation**

The Paper should be typed in 'Times New Roman' style, with font size 12, 1.5 line spaces between lines and the 1" margin on all sides. The manuscript should contain Title, Abstract, Keywords, Introduction, Materials & Methods, Results, Discussion, Conclusion, Acknowledgement, conflict of interest, author's contribution, list of References and brief about authors. The authors are expected to submit original scholarly articles in the following format.

**Title page** should have Title, Name(s) of the author(s) and their affiliations, phone no., corresponding author's email address(es) with name & affiliation.

**Abstract:** It should be informative and limited to 250 words and reflects all aspects of the study including results and conclusion, and explain the significance of the study.

**Keywords:** Keywords not more than 6, should be placed after the abstract.

**Main body:** Start the main body of the paper on the next page. All manuscripts should have a brief introduction with study objectives, materials & methods, results & discussion and conclusions. Headings should be bold and numbered. Also, if there are tables and diagrams included, these should be placed within the body of the paper near the text that refers to them. Must insert page numbers of the manuscript. The length of the text including references, tables and legends should be kept within 10,000 words for research and review articles, 3,000 words for Short Communications and 1000 - 2000 words for the Forum section.

**Acknowledgements** of people, grants, funds, etc. should be placed in a separate section before the References.

### **Author contributions**

For transparency, we encourage authors to submit an author statement file outlining their individual contributions to the paper.

**Conflicts of Interest:** All authors of submitting the manuscript to the journal must disclose any and all conflicts of interest they may have with publication of the manuscript that is mentioned in the manuscript. If no conflict exists, the authors should state: The authors declare that they have no conflict of interest.

### **Author Agreement for Copyright Transfer**

Before publication of article in JASIT Author must submit copyright transfer form.

### **References:**

Reference style

Text: All citations in the text should refer to:

1. Single author: the author's last name (without initials, unless there is uncertainty) and the year of publication;
2. Two authors: both authors' last names and the year of publication;
3. Three or more authors: first author's last name followed by 'et al.' and the year of publication.

Citations may be made directly (or parenthetically).

Examples: 'as demonstrated [Singh, 2021 (for single author) ; Singh and Rawat, 2021 (for two authors) and Singh et al., 2020 (for more than two authors)] have recently shown ....'

List: References should be arranged first alphabetically. More than one reference from the same author(s) in the same year must be identified by the letters 'a', 'b', 'c', etc., placed after the year of publication.

**Figures:** All photographs, graphs and diagrams should be referred to as a 'Figure' and they should be numbered consecutively (1, 2, etc.). Multipart figures ought to be labeled with lower case letters (a, b, etc.). Please insert keys and scale bars directly in the figures. Provide a detailed legend (without abbreviations) to each figure, refer to the figure in the text and note its approximate location in the margin. The resolution of figure must be at least be 300 dpi. Please avoid giving Figures as Fig.1a, Fig.1b, etc. Each Figure should stand alone.

**Tables** should be numbered consecutively (1, 2, etc.). In tables, footnotes are preferable to long explanatory material in either the heading or body of the table. Such explanatory footnotes, identified by superscript letters, should be placed immediately below the table. Please provide a caption (without abbreviations) to each table, refer to the table in the text and note its approximate location in the margin. The same data should not be presented simultaneously in tables and figures.

### **Peer Review Process**

All submitted articles will be initially subjected to editorial procedures if found suitable for publishing will be sent to reviewers for the **double-blind peer-review process**. Authors are also invited to suggest at least three potential reviewers who can review their article. It is not mandatory for the editor to send the articles only to the reviewer provided by authors; it is at the pleasure of the editor to send articles to any reviewer of his/her choice. The target for a first reply is three months. You may be requested by the Editor to submit a revision. Once the article will be found suitable to publish by reviewers, authors will be intimated for acceptance through email with the galley proof, which the author is insisted to reply within 48 hours, and then article will be sent for publishing. After publication, a PDF of published article will be sent to corresponding authors.
